



THE CORPORATION OF THE TOWN OF COBOURG

BY-LAW NUMBER 077-2015

A BY-LAW TO AMEND BY-LAW NUMBER 080-2014, BEING A BY-LAW TO REGULATE THE PARKING OF MOTOR VEHICLES.

WHEREAS pursuant to the provisions of the *Municipal Act, 2001*, Section 11, the Municipal Council of the Corporation of the Town of Cobourg enacted By-law No. 080-2014 on the 14th day of October, 2014 being a by-law to regulate the parking of motor vehicles;

AND WHEREAS it is deemed advisable to amend By-law No. 080-2014;

NOW THEREFORE the Municipal Council of the Corporation of the Town of Cobourg enacts as follows:

1. **THAT** By-law No. 080-2014 be hereby amended to include the following addition to Part XIII ROAD MAINTENANCE by adding Section 34.1 as follows:


34.1 No person shall park any vehicle on any roadway as outlined in the attached Schedule "O" between April 1st and October 31st during the hours from 2:00 A.M to 6:00 A.M for the purposes of general road maintenance.


2. **THAT** Schedule "O" to By-law No. 080-2014 is hereby amended by the addition of the following new wording regarding Road Maintenance:

"Covert Street from George Street to Division Street"
"Division Street from Covert Street to Lake Ontario"
"King Street from Ball Street to McGill Street"
"McGill Street from King Street to Charles Street"
"Queen Street from McGill Street to Division Street"
"Albert Street from Division Street to Hibernia Street"
"Second Street from King Street to Albert Street"
"Third Street from King Street to Hibernia Street." And
"Hibernia Street from King Street to Albert Street.

3. **THAT** Schedule "P" to By-law No. 080-2014 is hereby amended to include a Set Fine to be included for Section 34.1 regarding Road Maintenance.
4. That this By-law shall come into force and effect on the date that the Senior Regional Justice of the Ontario Court of Justice approves the Set Fine as set out in Schedule "P" for parking offences under this By-law and in accordance with the Provincial Offences Act, R.S.O 1990 CHAPTER P.33.

READ a first, second and third time and finally passed in Open Council this 10th day of August, 2015.
